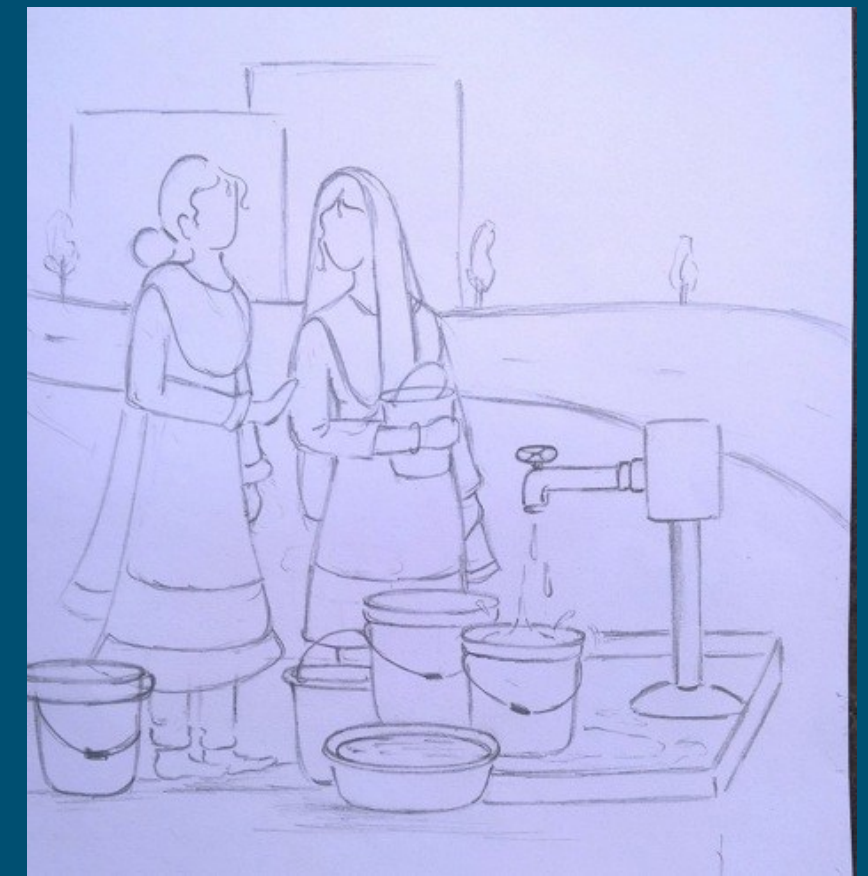
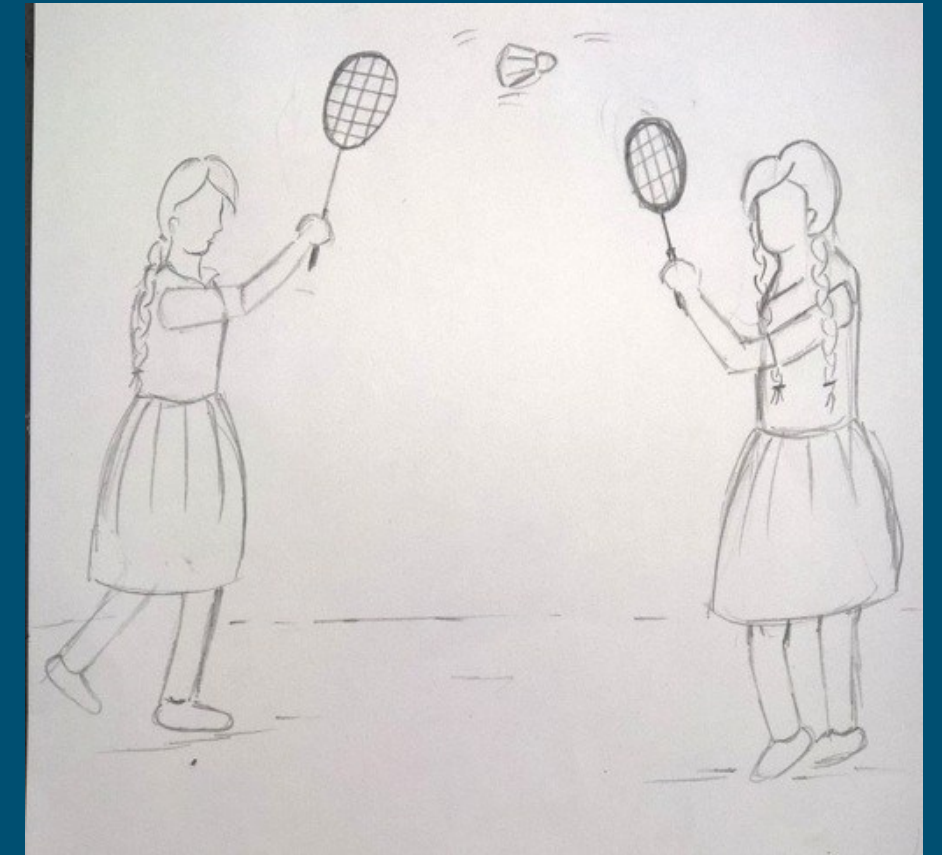

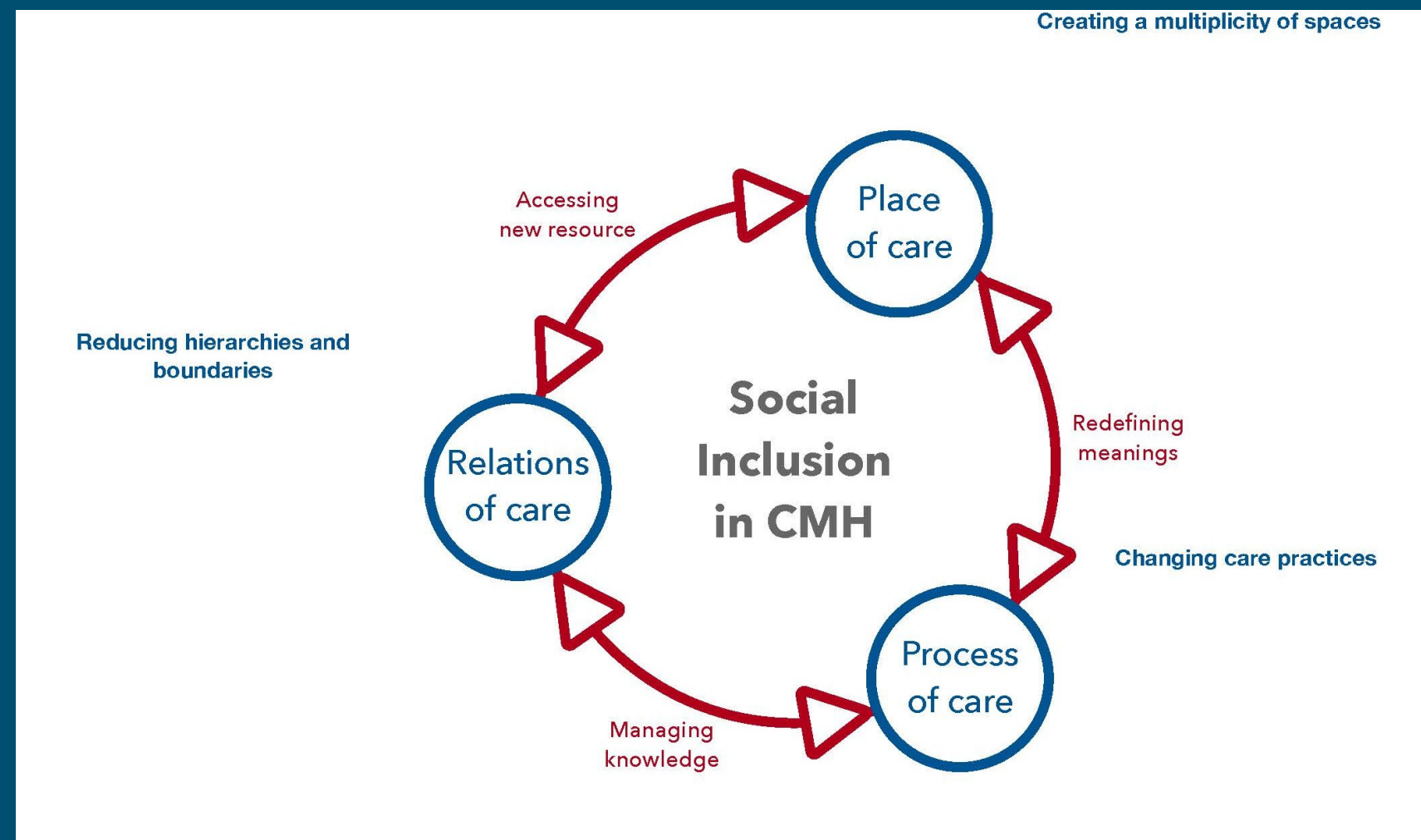

Why global mental health?

- How to address 'social suffering'?
- Social, structural and commercial determinants: mental health problems as inter-linked with poverty, inequality, and wealth.
- Mental health & well-being as development and human rights issues.

Key questions the programme aims to explore

- How are 'mental health' and 'distress' socially, culturally and politically constructed in different contexts?
- How do we theorize the intersections between social and economic development and mental health?
- What are effective interdisciplinary approaches to addressing the mental health / development interface?
- How can interdisciplinary and interprofessional approaches improve our understanding and practice of mental health in a global context?



Key aims of the programme

- Provide students with the tools for conceptual, methodological, and practice innovation in global mental health.
- Support an intellectual space for critically engaging with current research and practice to create transformative possibilities in global mental health.

- One-year full-time.

 - 3 x 20-credit required core courses
 - 3 x 20-credit optional courses
 - A 60-credit dissertation course

Critical approaches to Global Mental Health and Social Change

- On completion of this course, the student will be able to:
 - Develop critical understanding of the historically and culturally contextualized nature of 'mental health', 'well-being' and related concepts.
 - Critically engage with current policy and academic debates on approaches to addressing global mental health, well-being and social change.
 - Demonstrate conceptual understandings of how cultural and social factors shape mental health and well-being in the 'global south'.
 - Apply knowledge to critically analyse innovative policies and practice that address mental health, well-being and social change in the 'global south'

- By the end of this course you will be able to:

 - Apply conceptual understandings to critically examine policy and practice issues in cross-cultural mental health.

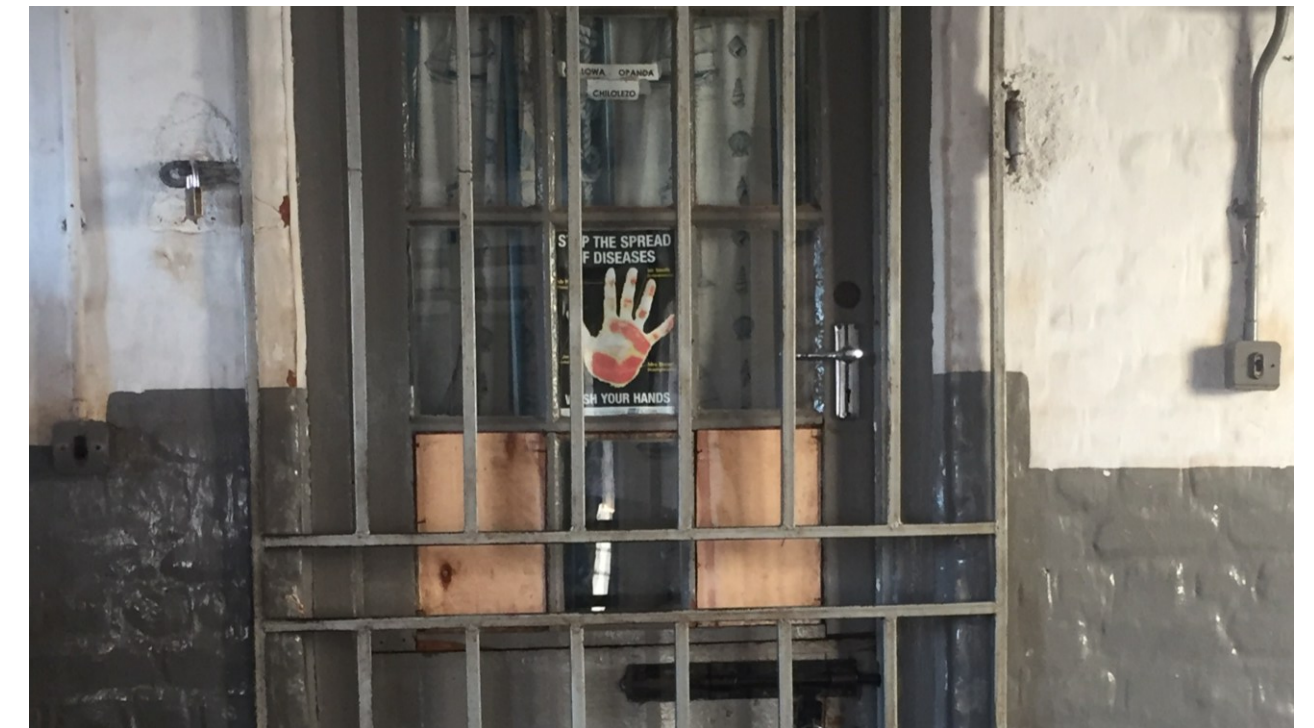

 - Use your knowledge to present an integrated perspective on global mental health to potential audiences.
 - Critically engage with current tensions in this field around inter-disciplinary approaches, as applied to implementation in global mental health.

Global Perspectives on Child and Adolescent Mental Health (PGSP11602)

- 20-credit optional course
- 2 assessments:
 - 1) 20% group presentation, and
 - 2) 80% written assignment
- Learning outcomes: On completion of this course, students will be able to:
 - Critically conceptualise childhood and adolescence in a global context
 - Identify the implications of the tensions around child and adolescent mental health policy and practice
 - Integrate disciplinary perspectives and frameworks to develop critical insight into child and adolescent mental health in a global context

Dissertation

- A single piece of independent and in-depth research. The 15,000 word dissertation allows you to focus on a preferred topic from within the field, normally based on a subject you have studied in one of your courses during the programme.
- You are supported to prepare for the dissertation through a taught course delivered September – March (4 sessions per semester) to introduce you to key methods and skills for the dissertation.
- You will be assigned an academic dissertation supervisor who will provide you with support and guidance while you research and write your dissertation.
- The dissertation is written in the summer months (April to August) after the taught courses are successfully completed.

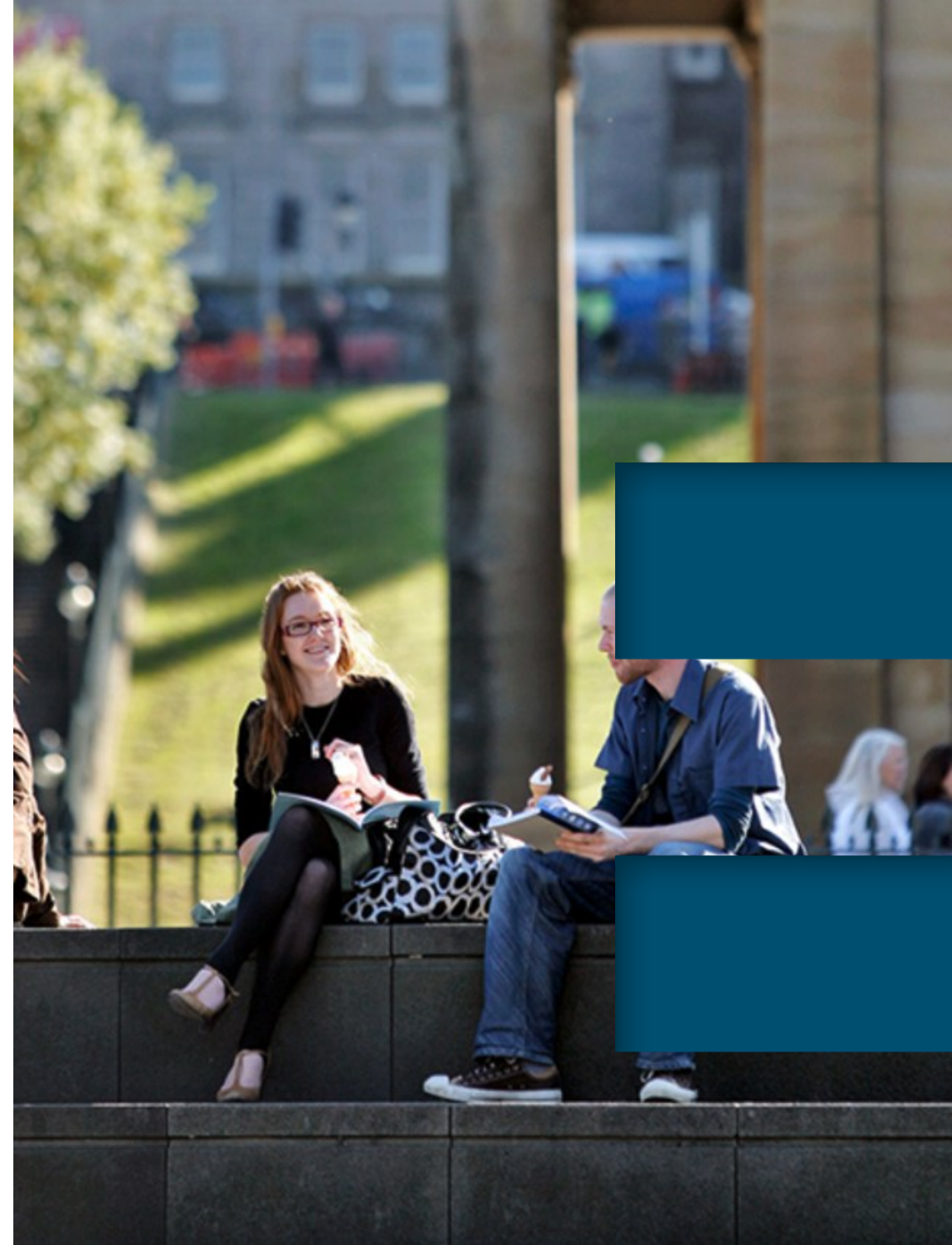

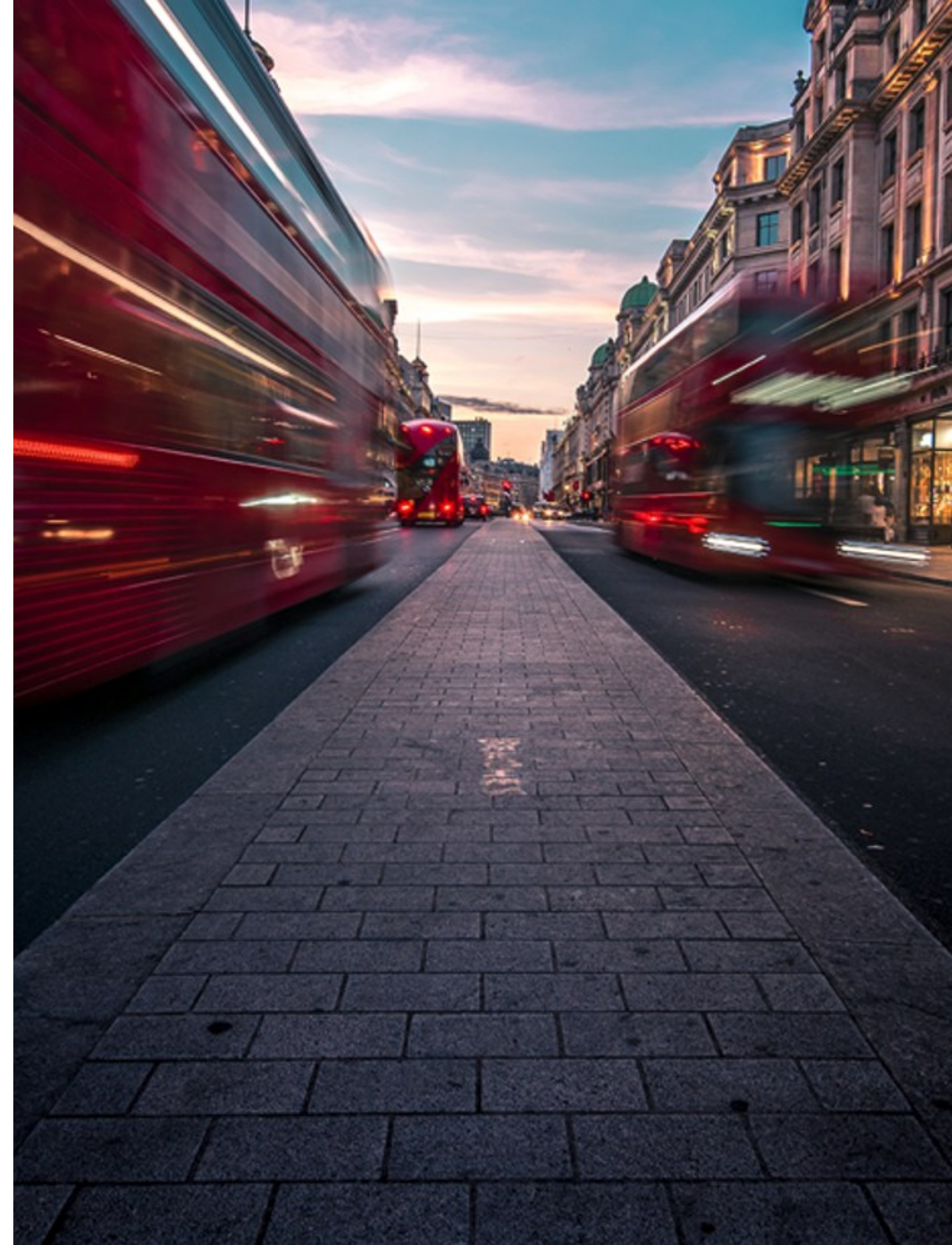
